

***A NOTE ON TEAM CREDENTIALS***

After careful review of the different circumstances and scenarios, the Oahu League Board of Directors has determined the following actions to be taken for the various situations that have arisen with player "write-ins" and other team credential discrepancies that have transpired during the Winter 2007-2008 Oahu League Season:

**ALL TEAMS MUST PROVIDE SOME SORT OF DOCUMENTATION OF WHICH PLAYERS PARTICIPATE IN THE GAMES. WITHOUT ANY DOCUMENTATION OF WHAT PLAYERS PARTICIPATED, THE LEAGUE CANNOT ASSUME THAT THE PLAYERS ARE LEGALLY REGISTERED TO THE TEAM IN QUESTION BECAUSE THERE IS NO RECORD OF SUCH.**

◆ **TEAM DOES NOT PROVIDE ADEQUATE LEAGUE ISSUED PROOF THAT ALL PLAYERS ARE ROSTERED TO TEAM AT GAME**

\*PLAYER CARDS ARE PRESENT, BUT NO ROSTER IS SUBMITTED TO GAME OFFICIAL

***PRESCRIBED ACTION***

- > GAME DEEMED A FORFEIT FOR TEAM LACKING CREDENTIALS WITH REGARD TO LEAGUE STANDINGS
- > TEAM PAYS THE MINIMUM FORFEITURE FEE TO THE LEAGUE - \$25
- > SUSPENSIONS MAY BE LEVIED ON COACH/TEAM AT THE DISCRETION OF THE LEAGUE

◆ **TEAM DOES NOT PROVIDE ADEQUATE LEAGUE ISSUED PROOF THAT ALL PLAYERS ARE ROSTERED TO TEAM AT GAME**

\*NO OFFICIAL/CURRENT LEAGUE ISSUED GAME CARD (PRINTED FROM AFFINITY SYSTEM), BUT RATHER AN UNOFFICIAL ROSTER

***PRESCRIBED ACTION***

- > GAME DEEMED A FORFEIT FOR TEAM LACKING CREDENTIALS WITH REGARD TO LEAGUE STANDINGS
- > TEAM PAYS THE MINIMUM FORFEITURE FEE TO THE LEAGUE - \$25
- > NO SUSPENSIONS LEVIED ON COACH/TEAM IF UNOFFICIAL GAME ROSTER MATCHES LEAGUE RECORDS

◆ **TEAM DOES NOT PROVIDE ADEQUATE LEAGUE ISSUED PROOF THAT ALL PLAYERS ARE ROSTERED TO TEAM AT GAME**

\*PLAYER WRITTEN IN ON EXISTING OFFICIAL/CURRENT LEAGUE ISSUED GAME CARD (PRINTED FROM AFFINITY SYSTEM)

***PRESCRIBED ACTION***

- > TEAM PAYS MINIMUM "WRITE-IN" FEE (\$25) FOR LEAGUE RETRO-ACTIVE PROCESSING OF REGISTRATION RECORDS
- > NO ACTION TAKEN, GAME STANDS IF "WRITTEN-IN" PLAYER MATCHES LEAGUE REGISTRATION RECORDS
- > COACH SHALL BE SUSPENDED 2 GAMES PER PLAYER PLAYED (PER GAME) THAT IS NOT PROPERLY ROSTERED TO TEAM (HYSA 2.11.1.2)

◆ **TEAM ALLOWS A PLAYER TO PARTICIPATE IN GAME WITHOUT A HYSA MEMBER PASS (PLAYER CARD)**

***PRESCRIBED ACTION***

- > GAME DEEMED A FORFEIT FOR TEAM LACKING CREDENTIALS WITH REGARD TO LEAGUE STANDINGS
- > TEAM PAYS THE MINIMUM FORFEITURE FEE TO THE LEAGUE - \$25
- > THERE IS NO GRACE PERIOD IN THIS SCENARIO (NO 15-MINUTE WAITING PERIOD). AS SOON AS AN UNCARDED PLAYER PARTICIPATES IN A OFFICIAL LEAGUE MATCH, THE MATCH IS DEEMED A FORFEIT.
- > SUSPENSIONS MAY BE LEVIED ON COACH/TEAM AT THE DISCRETION OF THE LEAGUE

***THESE ACTIONS WILL BE IMPLEMENTED BY THE LEAGUE, HOWEVER, DUE TO THE SIGNIFICANT NUMBER OF TEAMS THAT DID NOT HAVE OFFICIAL/LEAGUE ISSUED GAME CARDS FOR THE FIRST GAMES IN DECEMBER 2007, THE LEAGUE HAS DECIDED TO NOT PENALIZE TEAMS THAT PROVIDED A WRITTEN ROSTER THAT MATCHED THE LEAGUE'S REGISTRATION RECORDS DURING THE FIRST WEEKEND OF GAMES IN DECEMBER (12/9). TEAMS THAT HOWEVER ALLOWED PLAYERS TO PARTICIPATE IN THEIR GAMES THAT ARE DEEMED BY THE LEAGUE TO BE INELIGIBLE WILL BE PENALIZED IN ACCORDANCE WITH THE SANCTIONS LISTED ABOVE.***
