Kit: due to the proclamation for the summer, Mayor was not able to release the tier system without the governor; I don't think there is any realistic path to return to the fall season; Chris - we need at least 2 or 3 weeks of practice before we start a season; Scott - I believe with the 4 tier, we are still in the 2<sup>nd</sup> week of tier1? Kit - we are in the 3<sup>rd</sup> week of tier 1; Scott – haven't checked the metrics but the soonest to move to tier 2 is next week Thursday, 10/15; it doesn't change anything until we are in tier 4. That puts us in December, so there are lots of people lobbying & asking for changes; don't want to get everyone's hopes up so we probably won't be back with games until last week of December or January. Kit -1 was heavily involved in the retail group and worked with the restaurant association; the mayor was very supportive; lot of people have unrealistic expectations; encourage people to tell them they (State & C&C) are working on this but loud voices & going to the media will make these conversations harder. Chris – there are about 3000 people on the petition. Kit – the biggest problem frankly is the parents and the gathering. It's not about our kids playing but the activities around the kids; spectators should not be there; We can't transfer the money from Fall to Winter but we can do coupons. Saves us the time of refunding the money. Motion to cancel the Fall Season: Michelle, Scott 2<sup>nd</sup>, motion passed to cancel the fall season;

- v. Goal Proposal 4 goals 8x24, 4 goals 7x21 & third item are the wheels for the goals; Kwik Goal; any questions on the quote? Jen: Scott how does this compare with the last order? Scott: I support getting the Kwik Goal, complex opened in the fall of 2000, we have been opened for about 20 years this month.
