 - i. Significant Issues
 - 1. Tier 2 status ongoing difficult to say when we will start the season
 - Pushes back timeline for start of Competitive Winter Season. May have to consider merging winter/spring season to have a longer program for the 6-12U's
 - b. Expand field capacity if needed to utilize other parks (community parks)
 - c. High school season Jonathan said it is still up in the air whether a season will be happening
 - d. Alika teams want to play in a more relaxed environment, parents might want flexibility, as a league create an environment for both needs;

Old Business

- a. Guidelines for COVID19 return Alika's feelings on the winter competitive season;
 - i. Shakeout Season don't feel this is right at this time; teams are not ready to perform at their best or full capacity; not the right environment for Shakeout; option 1: can we push it back; no shake out this year but two shakeouts for two age groups next year? Option 2: have a mini tournament to see where they are and see where they are ranked; Option 3: CC will determine the ranking from the previous season; Discussion Scott motioned we do not hold a shakeout for the 2021 seasonal year for the 12U's, but looking into the future years, we will hold the shakeout for the 13U's in the competitive season; Jen 2nd; motion passed; Todd rules for shakeout will need to look at it; Chris will talk to Alika & at the Technical meeting for future discussion with the board

- c. Investment Policy Kit Milan how much to invest; long term/stable; what is our overall asset? Received the historical balances; \$560K closing; never went below \$440K in the past; we take \$250K designate as the corpus; what would be an appropriate asset allocation for that? ½ mixed income & ½ stock. Pretty conservative approach, good starting point.
