 - a. HYSA changed wording from Policy to "Guidelines"
 - Scott has had conversations with director of Waipio but nothing official yet and something will happen within the next week and a half but not certain;
 - HYSA is getting daily phone calls & are comfortable releasing it to the club with the caveat that we adhere to what the government entity tells us otherwise;
 - d. David-give our members guidelines to follow;
 - e. Chris will insurance cover a player injured, non COVID-19 related because they are practicing at the park when the state or city is not allowing it yet? Scott we have been so patient and it's been so long so it is pushing everyone one step further; not sure if we should post guidelines yet; Scott gave some of the people these guidelines but nothing concrete; David agree with what Kurt shared about liability; Chris we can make it very clear in phases; use the green light, yellow & red lights... Send out guidelines?

iii. Update on Strategic Planning

- Dave Pai is stepping down from being scheduler, Chris K will take over; not sure if Dave is doing the website; Sy texted Dave to inquire – will let Chris know;
- Meredith is now no longer the registrar; Sayoko will be doing the registrar duties;
- 3. Draft budget with Michelle P. and will be sending it over; game day operations Chris K will need to be at the field more often;
- 4. Athletic Trainers at Field. Plan to have that this season. Has been factored into the budget. NOTE: we had multiple fields where games were played

so that was the main reason why OL did not have trainers so have trainers at Waipia but not at Waiau DP or Waialae Iki was the issue question & the cost of having trainers.

- 5. AED Chris –there are no AED's there; the AED's there belong to the league; HYSA tournaments have trainers and they bring the AED's to the tournament; David motion to purchase an AED, Scott 2nd; discussion: Todd are there any grants to purchase this? Chris will look into it; motion passes
- 6. Match Analysis Chris went over the details;
 - a. Scott on cost; is the league paying the \$38K & \$42K, \$50/player; Mael – what is the cost per game?
 - b. David with the economy as it is, we should table it until we can move it in that direction; feels like a luxury item instead of a necessity;
 - c. Chris will work on a package for the clubs if they want it, they can get a better price instead of the league taking on the expense

Chris ongoing from what he can tell; Michelle P. we are not tied to them or anything? Chris no since we are not paying for this service, Chris Fisher abstained; motion passed

5. New Business

- a. True Age Policy Revisit for Developmental Season (not Scrimmage as we have Scrimmage Season in the Spring for the 12U & younger age groups) Fall 2020 – Todd I – can we do away with this altogether? Due to the pandemic and some other issues such as safety; clubs may be under more stress and we as a league have tons and tons of rules; random excuses that may come up; Scott – we had a conversation whether to relax for the fall & scrimmage season since it is not competitive; are we going to let the teams not follow rules one season and make them adhere to rules the following seasons? Talked about the true age number is the right number? 7 minimum for 11AS teams & 6 for 9AS teams; EX teams minimum was 4 for 11AS & 3 for 9AS. Realignment Rules updated for Scrimmage Season – Feb 2019 meeting; Todd motion for the Fall Developmental Season – remove true age policies for the Fall 2020 Developmental season for all age groups; 2nd Mael - Discussion: Kurt - keep the rules in place but no fines for whatever reason; keep the policy in place but suspend the fines? Chris – really look at the playing one year up only for the younger age groups; Scott – add that teams playing up two or one year is a related discussion; Todd is only addressing the minimum # of true age players; Scott – what Kurt is saying is better; Todd withdraws the motion; Kurt – remove the fines and keep the system as is and give everyone a warning; Scott – 2nd motion; motion passed; no objections, no abstentions,
- b. 808 Futsal & Honolulu Bulls West Dave T, James, Mael David T. subject matter information received about a partnership between 808 Futsal & Bulls SC to be able to play in outdoor league; spoke to Mael & Rodney Lee of Bulls on how the league brought futsal to the OL; OL can't control what the clubs do so Mael spoke; discussion with Kawika was to have a presence on the west side; David what is the league policy on the facility? We don't have any. Mael we will not be taking over the facility; we are not raiding players at all; Discussions amongst Mael, Kawika, James, David; Scott we need to make a decision about the league and if this partnership between Bulls & 808 Futsal will affect the League's futsal league? David said it's a discussion only. Whether we continue with the futsal league is only a discussion tonight. Wished Bill was on this Zoom meeting since he was the one who sent the email to Bulls. Todd to Kawika: how 808 futsal is going to explain to their memberships? How will it be promoted or not promoted? Kawika we have adult leagues, open play and OL league. 19 also uses the facility.
- c. Chris will be flying to see his family hopefully in the summer;
- d. Players can play up more than 2 years at 14U but Scott said 15U Scott is wrong. The following excerpt was taken from the National Championship Policy and under (2)(B) it does say 14U can play up three years. Or am I reading this wrong because I have been checking game cards for many years now & I look & memorized this rule.
- (c) A Team may have on its Team Roster only players of the following age groups for the seasonal year in which the Team is participating in the National Championships: (1) For Teams competing in the 13 and Under, 14 and Under, and 15 and Under age groups, each player on the Team must be (A) of the age of the age group competition in which the Team is participating in that seasonal year, or (B) of the age in either of the next 2 younger age groups of that age group competition in which the Team is participating in that seasonal year. (2) For the Teams competing in the 16 and Under, 17 and Under, 18 and Under, and 19 and Under

age groups, each player on the Team must be (A) of the age of the age group combined which the Team is participating in that seasonal year, or (B) of the age of any younge group, through the 14 and Under age group, of that age group competition in which Team is participating in that seasonal year. James shared —

Ask HYSA – Scott whether coaches need to take SafeSport & concussion courses again to be risk managed? Even though we opened in June for players, coaches will register in July and Robin will send out information then. Scott said more information will be sent in the coming weeks as coaches/admins are not able to register until July 1st. Also, he said that most likely coaches/admins will need to take the SafeSport & concussion courses again.
